Net Metering Program

The SFE Energy Illinois, Inc. ("SFE") Net Metering program is offered pursuant to Section 16-107.5 of the Public Utilities Act and Part 465 of the rules of the Illinois Commerce Commission (83 Ill. Admin. Code 465) and is available to residential or commercial customers who own or operate an on-site eligible renewable electric generator of up to 2,000 kW that generates electricity for the customer's own use and is intended primarily to offset the customer's own electrical requirements. In addition, the Net Metering program is available for customers with an interest in a Community Renewable Generation Project, such as a Subscription in a community solar project. Interested applicants should contact SFE. Eligible renewable electric generators include those powered by solar electric energy, wind, dedicated crops grown for electricity generation, agricultural residues, untreated and unadulterated wood waste, landscape trimmings, livestock manure, anaerobic digestion of livestock or food processing waste, fuel cells or microturbines powered by renewable fuels, or hydroelectric energy.

The Net Metering program will provide a customer credit for the excess generated energy that flows onto the distribution system according to the terms of your service agreement with SFE, as well as determine retail rate offset for reduced consumption.

Net Metering Program Requirements

- 1. The proper interconnection application form must be submitted to your utility to initiate the interconnection process for renewable electricity generating facility to the utility energy grid within 30 days of this application. SFE will cancel your authorization to net meter if you have not executed and returned to your electric utility an interconnection agreement with the electric utility pursuant to 83 III. Adm. Code 466 and provided the executed interconnection agreement to SFE within 12 months after receiving the interconnection agreement from the electric utility.
- 2. Verification of the installation of the appropriate type of electric meter. *For more information, please contact your utility.*
 - Please Note: Approval by utility and all prerequisites of service must be met prior to approval from SFE.
- 3. A Net Metering Application Form must be submitted to SFE to enroll in the Net Metering Program. The attached Application must be completed and mailed or emailed as noted on the application.
